PARK RENTAL RESERVATION

Thank you for your interest in Splash City. Please complete the following information and return it with your deposit payment for your party as soon as possible to ensure your reservation date. Reservations are made on a first-come, first serve basis and are only reserved when we receive your deposit payment, which is 50% of your total balance AND this signed contract. This contract must be signed and on file within seven days from the scheduling date. If the deposit and the signed contract are not received on time, the reservation will be forfeited. The total balance is due at least 30 days prior to the scheduled reservation.

Rates are for up to 300 guests. There is an additional \$3 charge for each guest over 300.

- Staff is to ensure that all rules are being enforced for the safety and enjoyment of the guests. It is not the duty of Splash City staff to entertain or babysit the children.

IN REGARDS TO CANCELATIONS AND PARK POLICY

Private parties cancelled by the guest more than 30 days in advance will receive a 50% refund of the deposit. Less than 30 days' notice will result in no refund. If a party is cancelled due to inclement weather, the guest may choose to reschedule or receive a refund without penalty. Once a private rental has started, a pro-rated refund will be issued determined by the amount of time remaining. Refunds will be issued in the form of a check written after the third Tuesday of each month.

DEPOSIT DUE AT BOOKING/ BALANCE DUE ON DAY OF RESERVATION

I understand that failure of myself or any member of my group to, at all times, observe and comply with these rules and the Splash City Waterpark rules may result in some or all of the members of my group to be asked to leave without refund. In consideration of the forgoing and as part of the application aforesaid, applicants agree to indemnify and hold harmless the Collinsville Area Recreation District, its' subsidiaries and the representatives from and against all actions, causes of action, claims, demands, liabilities, loss, damaged or expense of whatever kind or nature (including, but not by way of limiting reasonable attorney fees incurred) which said Park District shall or may at any time sustain or incur by reason of injury or death of others or damage to property of others arising out of or resulting from the use or occupancy by applicant or its' permitted of any property of said Park District pursuant to any permit granted hereunder.
